

Minutes of the Meeting of Lenham Parish Council Held on Wednesday 7th May 2025, 7:30pm at Lenham Community Centre

25/01 Election of Parish Council Chair. Elected chair to sign Declaration of Acceptance of Office

Cllr. A Walmsley proposed and Cllr. D Earl seconded the nomination of Cllr. J Britt. There being no other nominations, Cllr. J Britt accepted the nomination, and it was **RESOLVED** that Cllr. J Britt be re-elected as chair. Cllr. J Britt completed his Declaration of Acceptance of Office.

- c. Cllr. D Truner proposed, Cllr. D Garland seconded and it was RESOLVED to authorise using capital reserves (£25,911.88) to make up shortfall in s106 funds for the upgrade and the refurbishment of the play parks.
